EMERGENCY OVERVIEW

APPEARANCE

Scented white granular powder.

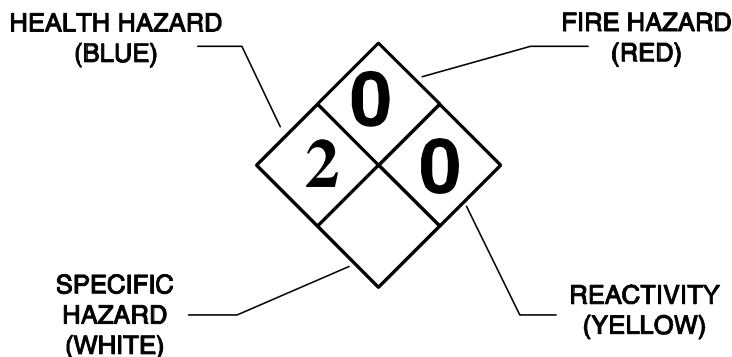

SECTION 7: HANDLING AND STORAGE
